Currently we have vacancies for a rep from Trelech/ Newcastle Emlyn and Carmarthen if anyone would like to volunteer.

Carmarthenshire has been divided into areas and

members will be notified of the meetings by email or by phone if members do not have an email address.

Meetings will not be routinely held, unless requested by the members, but consultation will be made on line and by phone although we will have an AGM once a year and the local group meetings. Updates will also be posted on the forum at http://carmsriders.clicdev.com. If you havent joined please do so and check out what is going on. Local events will also be posted here.

The first local group meeting was held at Fairfach for riders in the Llandeilo area. The issues raised at this meeting involved low flying aircraft and lack of

bridleways. The MOD in Partnership with the BHS are offering free Hi Viz tabards and sheets to those riders requesting them. Email modviz@bhs.org.uk with your name, address and the size of your horse or call 01926 707737. Preference will be given to those in flying areas.

The next meeting will be with the Carmarthen group. Anyone wishing to attend the meeting on the 17th July at 7.30. You will be very welcome.. Fox and Hounds PH at Bancyfelin. On a40 towards St Clears, take the right turn to Bancyfelin. Pub is near the school. If you reach the hospital you have gone too far.

Survey of all Routes

Many riders have been busy surveying local byways, bridleways and unclassified roads (UCR). If you wish to be involved in this exercise please let me know. I have some more routes to be looked at. They must be walked/ridden and not done from memory, the last time you used the route.

Currently, of the routes I have had returned, there is only 20% of the network open and easy to use. We have obtained an undertaking from the Highways Dept at C.C.C to look at maintaining the byways and UCRs if funding becomes available. Following this survey we will

be submitting an application for European and external funding to get a number of routes cleared/improved. This is with a view to get a regional trans Carmarthenshire promoted route created. We have to do this by December. This is our opportunity to get things improved locally, don't waste it!

What can YOU do?



The membership of the Carmarthenshire Riders spreads across the whole of the county. Unfortunately we are unable to monitor all the local news papers and community Mags for local news that affects riders. Please assist us by keeping us informed of any articles that appear that may impact or riders or where there is an opportunity for application to be made for consideration of improved routes. Postings can be made on the forum at http//carmsriders.clicdev.com or you can send a copy to me at Fernside, Black Lion Road,

Gorslas, Carms, SA14 6SB. The Counct Council advertise modification orders for public rights of way, including bridleways, in the local newspapers. Please inform us if there are any reported in your area. Once these have been approved they cannot be opposed.

Come to the local meetings or keep in touch by keeping us up to date on issues that affect you.

SURVEY

The results of the survey will be published on the forum in due course along with details of bridleways that are open and available and those that are closed. Please check out the forum regularly. Members without internet access will receive a report on the status of the network when the survey is complete to keep postal costs down. If anyone has any unsurfaced highways or tracks in their area it would assist if they could either email me or write to me giving a report on their condition and whether they are rideable. Most of these routes are marked as green dots on an Ordnance Survey map although some are

Slippery Tarmac

At the original meeting in Cwmifor slippery tarmac was raised as an issue. The County Council have agreed to test areas of new laid tarmac that is proving dangerous with a view to top dressing it. Please inform us through the forum or by phone if you have any new slippery tarmac in your area. It is only by raising this issue that the council will

review its materials.

Old tarmac is also an issue and should also be brought to our attention. If you are able to describe clearly the location—giving a serial number of a street light or a house name or number, or junction details, this will assist the council in testing the right area.

Mountain Riding



We have had a meeting with the Brecon Beacons National Park (BBNP)as a result of a query from a rider regarding stallions grazing on the Black Mountain. Enquires have been made with the council Commons Officer, Neil Evans, who keeps a register of grazing rights in the County. In the Black Mountain area the BBNP is keen to encourage

ponies on the mountain for environmental benefit. Therefore, even if a grazier does not have rights for ponies, they are prepared to issue written permission for their location. This means that riders must be careful when in mountain areas. I have written to the Chairman of the Graziers asking if we can be notified when the stallions are

present possibly by way of a notice as they are not there all year. Education seems to be the only solution in this situation and riders should stay as far away from grazing ponies as possible.

Mountain Riding Cont...

The BBNP do not allow riders off the rights of way in the park, although, where a rider sees grazing ponies they can take what ever avoiding action is necessary. This means taking a very wide berth and if you can tell the sex of a pony you are definitely too close. I am seeking advice from the graziers re suggested actions when coming across the ponies and aim to publish an advice sheet.

Riders riding on any mountain area should use the undergrowth and hills in the land to avoid the ponies seeing them and stay at least 800metres away at all times.

Stay quiet and observe their direction of travel. Generally they will keep moving. Wait for them to move on or divert. Riding off the path can be dangerous so follow the small sheep tracks which will avoid bogs and marshy ground but look out for rabbit holes. Watch the ponies constantly.

Should a pony break away from the group and take chase, move as fast as you can in the opposite direction to distance yourself from the group. This may be basic advice but many riders have no experience of mountain riding and are unaware of the dangers that a stallion poses. There have been incidents and riders have been seriously injured.

Forestry Commission Open Access

The Forestry Commission has designated most of its land as open access land under CROW 2000(there are exceptions). This means that walkers can access it freely and do not need to keep to footpaths. They have also given riders open access although there are some restrictions on parking. Abergorlech in Brechfa Forest is one of those restricted areas. Cycle tracks have been laid in

the area and the car park is considered too small for multi user parking. If any of these restrictions cause you inconvenience I will take the matter to the Forestry to see if we can resolve it.

Map Reading Event

At the start of this group whilst talking to Ed Saunders at the Forestry Commission it was suggested that riders need some tuition involving maps as many undertake riding in the forestry without a map and get lost and those reporting problems cannot give suitable map references to assist in the maintenance of the routes. Given that Brechfa Forest is

such a large place with few land marks and a risk nighmare, I decided to start small and offer an event to local riders/members and Pony/Riding Clubs. My intention is to introduce maps to the group with a view to running an event at Pembrey. I have decided on Ammanford as I had hoped to get access to the Black Mountain. This is

still under discussion but will include some instruction to be read prior to attending the event, some instruction explaining the reading provided and a short ride out to put new found skills into practice. Maps will be provided and riders will have to ride in 3s for safety. Clues will be collected along the way for a quiz at the end for which


