We have written to the Trunk Roads Agencies to ask about the procedure they adhere to for the control of Ragwort. Having shown an interest in the issue we plan to inform the agencies of weed growing alongside trunk roads next year and have added the criteria and reporting forms to the website www.carmsriders.co.uk. We will be running a photographic competition next year to encourage reporting and to put a little pressure on DEFRA to take action against the Agencies where the plant is growing near hay fields or fields used for grazing.

The tracks are being dusted following the completion of extraction works however the tracks will be easily damaged and riders are asked to be considerate in their use until they have settled. The council is considering a permit scheme for this area because of the damage done to the tracks already completed. The access at Melleys is under threat due to safety issues although Melleys are willing to consider a mirror being placed on their fence. I am attempting to establish a regular meeting with the staff at Llyn Lech Owain to obtain better communication and signage. Minutes

Minutes of Decision Maker Meetings and other meetings attended by group reps can be obtained on request.

We now have regular 3 monthly meetings with CCC Highways and access departments. We also meet with Forestry Commission and the BHS at least annually. We also have representation on the CCC Walks and Trails meeting and the Local Access Foum. For anyone in the Llansteffan/Llangain area, I will be meeting with the Coastal Path Officer shortly and am looking for riders with local knowledge of the coast in this area who can advise me.

Improved Access Opportunities

As a result of the meetings with Highways Dept, the council are going to improve surface and signage to a number of vehicular routes in the Llanfynydd area. The improvement of these byways/unsurfaced highways will give additional access to riders and, because they are used by more than one user group, the improvements will be more cost effective. The routes concerned are being surveyed for suitability. If you have other routes to be considered for improvement that are sustainable for use by 4x4 vehicles and will provide improved access for riders let us know. There are approximately 150 kms of these vehicular routes, which would more than double routes available to us. By working with the vehicle groups we can improve off road access.
